1 Summary

The biannual 2016 Tuition Survey Report is a summary of the responses we received to a survey we conducted in the fall of 2016. A total of 292 schools responded. A special thanks to all who participated.

<u>Demographics</u>. The results of the survey represent 292 private and parochial schools. This represents a good cross section of the United States (see page 4). The schools represented in the survey come from varying community sizes (38% of schools in communities > 100,000 people). The majority of schools responding had less than 101 students enrolled (55%). We summarize tuition for each class level overall, as well as by geographic location, population, and enrollment.

The schools represented in this survey also have varying school year lengths. We therefore report monthly tuition, in order to account for varying school length and allow for comparison across schools.

<u>Tuition</u>. The primary responsibility for setting tuition belongs to the head of school and the school's board of directors (59%). The three most important factors used to determine tuition are budgetary expenses (54% of schools reported this as the most important factor), teacher/staff salaries and benefits (51% reported this as the second most important factor), and changes in the cost of living (53% reported this as the third most important factor).

For the 2016 - 2017 school year, 42% of the schools increased tuition 3 - 6%. This compares with 53% of schools increasing tuition 3 - 6% in 2014 - 2015 (as detailed in our 2014 Tuition Survey Report). Eighteen percent of schools responded that they had had no tuition increase compared with 12% from the 2014 Tuition Survey Report (see page 10).


Most schools (88%) offer reduced tuition for children of their faculty and staff (a 2% decrease from that reported two years ago). Among these schools, the percent reduction ranged from 10% to 100%. Most (63%) also offer partial scholarships for children other than children of faculty and staff. This percentage dropped 5% from 2014 - 2015. Reduced tuition is offered for families with more than one child at the school at 58% of the schools.

The average percent of budget earmarked for scholarships was 6.6%, as compared with 9.05% and 5.94% in the last 2 surveys (2014 - 2015 and 2011 - 2012 school years, respectively).

<u>Standardized Testing</u>. This year two questions were added to the survey related to standardized testing. Be sure to take a look at the interesting results found in Section 6.


2 Definitions

- Geographic Regions
 - Midwest: Illinois, Indiana, Iowa, Michigan, Minnesota, Missouri, Ohio, and Wisconsin
 - Northeast: Connecticut, Delaware, Maine, Massachusetts, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, and Vermont
 - Plains: Arizona, Colorado, Kansas, Nebraska, New Mexico, North Dakota, Oklahoma, South Dakota, and Texas
 - Southeast : Alabama, Arkansas, District of Columbia, Florida, Georgia, Kentucky, Louisiana, Maryland, Mississippi, North Carolina, South Carolina, Tennessee, Virginia, and West Virginia
 - West: Alaska, California, Hawaii, Idaho, Montana, Nevada, Oregon, Utah, Washington, and Wyoming
- Length of School Year
 - Full Day: more than 4 hours
 - Half Day: 4 hours or less
 - Extended Day: Hours outside regular school hours (e.g., 8:15 am 3:15 pm)
- Statistical Summaries. In general, categorical variables (e.g. Geographic Region, Community Type, Enrollment, Yes/No questions) are summarized with the number (N) and percent (%) of people in each response category.
 - N: refers to the number of people who responded to a question. A blank cell indicates no responses received, an asterisk indicates not enough responses received to ensure a large enough pool of information to guarantee a statistically significant number from information that is sufficiently aggregated so as to ensure anonymity. When an asterisk is included, a total number representing that information category will include the hidden statistical information represented by the asterisk, because at that point, the data will be sufficiently aggregated so as to be statistically significant, allowed, and in conformance with antitrust laws.
 - Mean (also known as "Average"): the sum of all values divided by the number of values
 - Median: the middle value in a list of ordered values
 - Mean vs. Median: The mean is sensitive to extreme values whereas the median is not. For example, consider the set of 5 values: 101, 102, 103, 104, 105. The mean and median of these values both equal 103. Now consider a set of 5 values, where the 101 from the previous set is replaced by an extreme value, say, 0. Then the mean of these values is 82.8, but the median is still 103.
 - Mode: The number which appears most often in a set of numbers
 - Standard Deviation (SD): a measure of the variability of values around their mean, with greater SD reflecting greater variability.
 - Min: refers to the minimum reported value
 - Max: refers to the maximum reported value
 - Median: the middle value in a list of the ordered values
 - Blank cells indicate no responders in that category
 - An asterisk (*) indicates fewer than 5 responses received and it therefore not statistically significant
- Monthly Tuition Rates:
 - The schools represented in this survey also have varying school year lengths. We therefore

Figure 1. Geographic Location







Figure 2. Community Type






Figure 3. School Size by Enrollment


